Community Health Information Subsystem in Mozambique

In Mozambique, Digital Square is supporting the Ministry of Health (MOH) to build a new community health information subsystem to advance the primary health care for universal health coverage agenda. One of the pillars of the community health subsystem strategy is the design and implementation of a community health information subsystem that integrates digital tools.

As part of Phase 3 of the Digital Community Health Initiative (DCHI), Digital Square has been supporting the MOH to develop the Community Health Information Subsystem Implementation Plan to strengthen community digital health governance and to expand the use cases and functionalities for community digital health tools.

upSCALE, a digital health tool used by community health workers (CHWs), is currently being used in many health domains, including prenatal care, newborn screening, postpartum care, family planning, nutrition, HIV, TB, and COVID-19 (for educational messages). This digital tool, based on CommCare, also aids CHWs in treating malaria and diarrhea, if present.

upSCALE was intended to be scaled up for national use with the *Community Health Information Subsystem Implementation Plan*. However, governance issues regarding its use led to the development of a parallel system based on District Health Information Software 2 (DHIS2) capture.

Digital Square played an instrumental role in increasing coordination and governance, and it successfully advocated against the use of a dual system that would burden CHWs with additional training and dual entry. As a result, in March 2023, the MOH reached a consensus on using upSCALE as the sole community digital tool for national rollout through the community health information subsystem.

About this project

The U.S. President's Malaria Initiative (PMI) launched its Digital Community Health Initiative (DCHI) with a vision to strengthen quality health delivery at the community level. Led by USAID and co-implemented with the U.S. Centers for Disease Control and Prevention (CDC), this initiative aims to invest in the scale-up of digitally enabled community health platforms. DCHI is implemented by PATH's Digital Square initiative and its subawardees, including John Snow International, Last Mile Health, and Population Services International. Implementation of an Electronic Community Health Worker (CHW) Registry in Zambia

Digital Square is supporting the Zambian Ministry of Health to implement the electronic Community Health Worker registry throughout the country to improve the community health information system and enhance the delivery of malaria services by CHWs. To support this initiative, Digital Square is conducting user training workshops in four provinces (Southern, Eastern, Central, and Luapula) with the goal of achieving nationwide utilization of the electronic CHW registry.

The registry is a KoboCollect mobile application designed for use by health facility staff who supervise CHWs in their areas, with the purpose of gathering and reporting data on CHW deployment, saturation, and attrition to the MOH Human Resource Information System (HRIS).

Thus far, Digital Square has provided training to 125 health care workers, including nurses and environmental health technicians (EHTs) at the health facility level, community health officers (CHOs),

and information officers who work at district and provincial management levels. These training sessions are conducted as "training-of-trainers" workshops, where participants will then disseminate the knowledge gained to other health facilities within their respective districts.

Digital Square has continued to support the MOH to provide technical supportive supervision of the CHW registry in Southern and Eastern Provinces. The CHW registry will improve management and planning of the community-based volunteers and harmonize gray areas that have been identified, such as fragmentation. During the visits, the Provincial Health Director, the District Health Director, the District Health Officer, facility staff, the EHT, and community focal point personnel met to discuss the importance of the CHW registry and its long-term impact on managing and planning for CHWs through the HRIS.
